**A Resolution Adopting the CY 2022 Town Tax Levy as Set by the Town  
Electors at a Special Meeting of the Town Electors; And Adopting the Town's  
CY 2023 Budgets  
as Presented by the Town Board**

**WHEREAS**, Section. 60.10 (1)(a) of Wis. Statutes authorizes the Town Electors of the Town of Clayton, County of Winnebago, State of Wisconsin, to adopt the Town Tax Levy at a Special Meeting of the Town Electors; and

**WHEREAS**, at the Special Meeting of the Town Electors of the Town of Clayton, County of Winnebago, State of Wisconsin, the Town Electors did by a majority vote of the eligible Electors voting on this 16<sup>th</sup>, day of November, 2022 resolve and order as follows:

- 1) By motion, the Town Electors of the Town of Clayton, County of Winnebago, State of Wisconsin have adopted a Town Tax Levy for CY 2022 payable in CY 2023 of \$2,442,060.00.

**NOW THEREFORE BE IT RESOLVED**, that the Town Board for the Town of Clayton, County of Winnebago, State of Wisconsin resolves and orders as follows:

- 3) To adopt the Town's CY 2023 Capital Projects Fund Budgets as presented.
- 4) To adopt the Town's CY 2023 Debt Service Fund Budgets as presented.
- 5) To adopt the Town's CY 2023 Stormwater Management Utility Fund Budgets as presented.
- 6) To adopt the Town's CY 2023 Solid Waste and Recycling Fund Budgets as presented.
- 7) To adopt the Town's CY 2023 Tax Increment Finance District #1 Fund Budgets as presented.
- 8) To adopt the Town's CY 2023 Sanitary District #1 Budgets as presented.
