II. Select Board of Review Chairperson

MOTION:

Town Board Chair Geise nominated Supervisor Lettau as Chairperson for Board of Review Nomination was seconded by Supervisor Grundman

Motion carried by unanimous voice to approve Kay Lettau to be Chairperson of Board of Review

- III. Assessor Luke Mack, Associated Appraisal Consultants, Inc. turned over CY 2021 Assessment Roll for the Clerk to sign.
 - Mr. Mack discussed the following topics with members of the Board:
 - o Town of Clayton performed a full (100%) revaluation
 - o Change in Assessment Letters were mailed April 27, 2021
 - Open Book was held May 7, 2021
 - Due to continued Covid-19 pandemic conditions, Open Book was primarily conducted via phone with a few office appointments and a few site visits up to 48 hours prior to convening of the Board of Review.
 - Average assessment increased just under 10 percent
 - Valuation total is \$552,444,500 including personal property but without the Manufacturing assessment

• Mr. Mack reported one error in assessment was found during open book—Bill Lynch, 2961 W Shady Lane. The square footage of the second story was over calculated. Corrected value from \$507,300 (2020) to \$468,800 (2021) resulting in a refund of \$687.83 which will go through the charge back process.

The Board of Review reviewed the correction.

- Ron Hawkinson, 8879 Clayton Ave, made a request to ask questions regarding his assessment.
- The Board explained Mr. Hawkinson did not meet the required deadline to file an intent to object with the Clerk 48-hours prior to the meeting.
- Mr. Hawkinson explained he did not realize there was a deadline but he felt the assessment was too high.
- The Board explained that Assessor is assumed to be correct unless there is a preponderance of evidence showing otherwise.
- Mr. Hawkinson said he did not have any evidence to support his opinion of value.
- The Board explained the Assessor revalued all of the properties in the Town and the values are based on comparable sales which had occurred within the last 12-24 months.
- Mr. Hawkinson thanked the Board for hearing his concerns.

- Matteo Sollena, 9639 Clayton Ave, made a request to ask questions regarding his assessment.
- The Board explained Mr. Sollena did not meet the required deadline to file an intent to object with the Clerk 48-hours prior to the meeting.
- Mr. Sollena explained he did not realize there was a deadline but he felt the assessment was too high.
- The Board explained that Assessor is assumed to be correct unless there is a preponderance of evidence showing otherwise.
- Mr. Sollena said he did not have any evidence to support his opinion of value however, his value was increased by \$20,000 in 2020 and now in 2021 by another \$46,400. He asked how often the Town revalues properties.
- The Board explained the Assessor revalued all of the properties in the Town this year and
 is performing full revaluations every other year in order to maintain compliance with the
 required State standards.
- Mr. Mack asked Mr. Sollena if he thinks he could sell his home for \$468,000 which is the assessed value of his home.
- Mr. Sollena said he could likely sell the home for that price but did not intend to do so.
- Mr. Mack explained the increase in assessed value does not necessary equate to a proportionate increase in taxes—the tax levy is spread over the full value of the Town and often times the taxes are not impacted significantly
- Mr. Sollena thanked the Board for hearing his concerns.
