A. Review/Recommendation: Plan Commission review and recommendation on purchasing

of gift cards for the Comprehensive Plan Update Citizen

Opinion Survey incentive.

The Commissioners advised the 5 gift cards should be purchased from the local BP station and requested that Staff make the purchase and contact the selected respondents.

B. <u>Review/Discussion</u>: Plan Commission review and discussion on results of the Comprehensive Plan Update Citizen Opinion Survey.

The Commissioners reviewed the results of the Citizen Opinion Survey with Mr. Fowle and Planner Jaworski of Cedar Corp. Mr. Fowler noted that the response rate was tremendous. Highlights of the summary discussed by the Commissioners were: 1/3 of respondents were retired, 1/3 of respondents thought there should be more housing development of under 1,300 sq ft homes; and a majority of respondents were in favor or more biking facilities. Planner Jaworski noted the desire for no new job creation in the Town to be surprising, but the Commissioners pointed out the perception that there are many existing jobs in the Fox Valley so the need may not be perceived to be great within the Town. Chair Knapinski noted that taking the top 5-10 concurrences from the results and addressing them in the Comprehensive Plan changes already being discussed may be something to consider moving forward.

C. <u>Review/Discussion</u>: Plan Commission review and discussion on the proposed Tiered Future Land Use Map.

The Commissioners continued discussions regarding the proposed tier map. The Commissioners further evaluated the proposed boundaries of the tiers, and proposed changes for review at the next meeting setting more distinct borders between Tiers 1 & 2 as the urbanizing and transitional tiers, and Tier 3 as the more rural area. The Commissioners discussed the place for Working Lands in Tiers 2 and 3, and what (if any) commercial developments would be appropriate in Tier 2. The Commissioners discussed a possible percentage cap for population growth in each tier, similar to a plan implemented in Village of Greenville. The Commissioners asked for more information on that particular plan, and will revisit discussion at a future meeting.

D. <u>Review/Discussion</u>: Plan Commission review and discussion on designation and implementation methods including A-1 and A-2 zoning.

The Commissioners preliminarily discussed how to address Winnebago County phasing out the A-1 zoning designation within Town zoning. Chair Knapinski noted that Village of Greenville has created some type of agricultural zoning, but the Commissioners would need more information before making a recommendation for changes.
