ORDINANCE NUMBER 2022-004 AN ORDINANCE TO AMEND THE TOWN OF CLAYTON HIGHWAYS 10 & 76 CORRIDOR LAND USE MASTER PLAN & THE TOWN OF CLAYTON COMPREHENSIVE PLAN 2016-2036

- WHEREAS, pursuant to the provisions of Section 62.23(2) and (3) of the Wisconsin Statutes, the Town of Clayton is authorized to prepare and adopt a Comprehensive Plan for the Town's vision of the future growth and development of the community as defined in Section 66.1001(1)(a) and 66.1001(2) of the Wisconsin Statutes; and
- WHEREAS, the Town Board of the Town of Clayton, Wisconsin, has previously adopted written procedures designed to foster public participation in every stage of the preparation of the comprehensive plan as required by Section 66.1001(4)(a) of the Wisconsin Statues; and
- WHEREAS, the Town of Clayton, through its Plan Commission and through community participation, with the assistance of Cedar Corporation, prepared and adopted the *Highways 10 & 76 Corridor Land Use Master Plan* as part of the Town of Clayton Comprehensive Plan, a copy of which is on file in the Office of the Town Clerk and is posted on the Town's website; and
- WHEREAS, the Town of Clayton Plan Commission has previously held a Public Hearing to solicit further input on the proposed Amendments to the *Highways 10 & 76 Corridor Land Use Master Plan* as required under the provisions of Section 66.1001(4)(d) of the Wisconsin Statutes;
- NOW THEREFORE BE IT ORDAINED THAT, the Town Board of Supervisors of the Town of Clayton, County of Winnebago, State of Wisconsin, hereby adopts the following Amendment(s) to the Town of Clayton Highways 10 & 76 Corridor Land Use Master Plan & The Town of Clayton Comprehensive Plan 2016-2036:
- SECTION 1: The Highways 10 & 76 Corridor Land Use Master Plan & Comprehensive Plan 2016-2036 is amended as follows:

Property Owner(s):

- **SECTION 5:** That this Ordinance shall take effect immediately upon the passage and publication of the same as made and provided by law.
