4. Review of TID #1 Annual Report - 2021

Chair Straw and Consultant Hinz presented the following: **NOTE** that these numbers are unaudited and will change once audit is complete

TID Fund Balance as of January 1, 2021: \$340,412 Revenues primarily from Debt Issuance: \$9,102,264

Expenditures: \$8,281,785

TID Fund Balance at end of year: \$1,272,398

Future Costs: Not known at this time – awaiting audit Future Revenues: Not known at this time – awaiting audit

- Board Member Knapinski questioned if the TID is still on track with what was projected.
- Chair Straw noted that growth has not been as expected or predicted, but there are several developments in discussion at present.
- Chair Straw noted there are 96 apartment units going up that will be completed by end of CY 2022, and another 80-126 units coming in. Chair Straw reported there has been expressed interest in a manufacturing development on an 8-acre parcel in the Town, which would require W American Dr to be put through.
- Chair Straw noted that the properties included in the Gold Shovel Program are being more heavily marketed.
- Board Member Knapinski asked what the projections are for next year, and Chair Straw
  noted the audit has not been completed, so that information is not available at the time of
  the meeting. Chair Straw noted that while the TID will be paying back debt for quite
  some time, the development of the new Neenah High School, a proposed mixed housing
  development on a 103-acre parcel, and the possibility of development on some of the
  currently privately held land west of the new school site will generate significant
  increment.
- Consultant Becker replied that although the increase in interest rates will have a breaking
  effect, the demand for housing is so high that there may not be a significant decrease in
  development.
