The minutes of the May 5, 2015 were reviewed. A motion was made by Mike Kinney and seconded by David McNamee to approve the May 5, 2015 minutes.

David Klockzien's user bill was discussed. Mr. Klockzien wondered if his bill could be reduced as the number of the people living in his home has been reduced. His bill was a set rate of \$100.00 a quarter instead of amount used as his meter was removed because of sand, etc. that destroyed three or more meters. After discussion a motion was made by Mike Pfankuch and seconded by Mike Kinney to reduce the rate down to \$80.00 a quarter. Motion carried unanimously.

A motion by Mike Kinney and seconded by Mike Pfankuch to allow her a credit for this water. Motion carried unanimously.

New London Tree Service backed out of job by the Ponds because some of the trees would be too tall for them to manage. They suggested we contact Treo Trees for this job. Mike Pfankuch will contact them plus one other Co. to get estimates.


