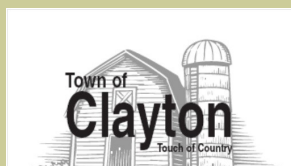

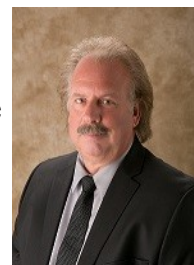

### From the Desk of the Town Chairman



First, I would like to thank everyone for the trust you have placed in me at the April elections. Working together we can continue to move the Town of Clayton forward while ensuring our quality of life for today and tomorrow. I would also like to acknowledge and thank Mark Luebke for the eight years of service he dedicated to our Town as the Chairman.

Summer time means our Public Works Dept. will be out working hard on all of the projects that have been scheduled for this year along with regular road and ditch maintenance. Just an update on a few of them: #1. Oak Openings Subdivision, currently installing drain tile and ditching with roadway work to begin. #2. Winncrest Subdivision, relocation of gas main and telephone lines to be done in June prior to roadway work. #3. Oakcrest Subdivision, finalizing relocation of gas main, ditch and roadway work expected to begin in June.

The Town Plan Commission is currently working on an updated 2015 Comprehensive Plan and a public hearing will be scheduled so we get thoughts and input from our residents on the future vision for our Town. As always the date will be posted. Please check the website.

As a Town we are also now facing the incorporation of the Town of Menasha. On June 5<sup>th</sup> they petitioned the court to move ahead to become the Village of Fox Crossing. This could have serious implications for our Town. Here is why: Towns cannot annex other Towns. However, Villages and Cities can annex and the future Village has made it very clear it is their intent to annex our east side up to and maybe beyond highway 76. They will have the ability to offer services such as sewer and water that we currently do not, and the business base we have there wants and needs these services. We will be fighting this incorporation to not only preserve 12% of our land mass but the 14% (almost \$49 million dollars) of equalized value in the Town. Future growth will happen regardless if it is Clayton or the new Village of Fox Crossing, especially along the Hwy 10 corridor. I feel it is in our best interest to make sure it is the Town of Clayton not the new Village that dictates our future.

Nearly all of us have put together a giant picture puzzle at some time. When all the pieces first dumped out, it looks like, well, nothing. Certainly nothing like the picture on the box. Only by picking through all the pieces and finding the ones that fit together do we start to see the image that we wanted to create.



On June 10th, the Clayton Town Board, Plan Commission and Green Space Committee had a rare joint meeting to kick off the yearlong update to the town's comprehensive plan. It was, so to speak, the opening of the box and the dumping of all the pieces onto the table. The three groups were brought together so they all had the same knowledge base to consider as we began the process to update the town's future vision.

Right now all the diverse pieces – some showing trends, or perhaps demographics, or maybe ideas – don't seem to fit together. Only time, patience, and observation bring the answers.

Each of the town's governing bodies has an important role to play. The Plan Commission will fuse the elements of what we residents want the town to look like, using demographics, outside influences, economics, and public input. The Greenspace Committee will study the town's recreation resources now and what residents and visitors may want in the future. The Town Board, as your elected representatives, will ultimately approve the plan, then set the policies and find the financial means to bring it to reality.

Even in an initial meeting, some trends and desires were evident:

- The town is determined to maintain its borders and continuity. The potential incorporation of the Town of Menasha is a threat to that and to the town's tax base.
- There is a desire to maintain elements of commercial business, residential, and agriculture.
- What the next 25 years will look like in the town will not look like the past 25 years.

What's next? The Plan Commission will spend the next few months putting an initial update together, then bring it to the next public information session.

This is where YOUR input is important. We didn't expect a lot of members of the public at the June 10th meeting, and we weren't disappointed. Summer is short and great evenings are to be cherished. That, however, doesn't minimize the importance of the comprehensive plan to the town or the necessity of doing the planning the right way. That includes your responses and ideas. This town belongs to each of us and all of us. We want your input as a part of what Clayton will be.

## Summer Safety Tips

### Tick Bites

Ticks are responsible for a variety of illnesses including Lyme disease and Rocky Mountain Spotted Fever. These diseases can be very serious. Learn ways to protect your family. Some suggestions include:

- Protective clothing (long sleeves, long pants, tucking pants into socks)
- Tick/bug repellant for people and pets
- Staying in the center of paths, keeping away from overgrown areas and not sitting directly on the ground
- Performing tick checks on all family members every day
- Being aware of signs/symptoms of tick-related illnesses and calling the doctor for any concerns/questions



### Sun Protection

- Avoid sun exposure during peak sun hours (10 AM – 6 PM).
- Wear protective clothing and a wide brimmed hat and sunglasses (with 99-100% UV protection).
- Sunscreen is a must (on sunny and cloudy days)! Look for products with UVA and UVB protection and an SPF of at least 15 (according to the American Academy of Pediatrics and American Association of Dermatology).
- Sunscreen should be applied liberally 30 minutes before going out in the sun, and reapplied every two hours or sooner if swimming, sweating or toweling off. Look for shade whenever possible.

### Summer First Aid Kit

- Every family should have one first aid kit at home and in your car which is well stocked and accessible.
- Kids get lots of cuts and scrapes during the warm summer months, so it's nice to be prepared.
- Don't forget to restock the kit once an item has been used.
- Be sure to keep a list of emergency numbers where they are easy to find. This list should include: emergency medical services (911), the doctor's number, the dentist's number, poison control, a number where mom and/or dad can be reached and any other important phone numbers.

### Dehydration and Heat Related Illnesses

- Keeping well hydrated is very important.
- Children (and adults) must remember to drink.
- Do not wait until a child says he is thirsty before offering fluids. At this point, he is already dehydrated, so be sure to provide plenty of fluids before going outside, while out in the heat and afterwards.
- Playing in the hot summer sun means lots of fluid losses, so avoid strenuous activity during peak sun hours (10 am- 6 pm). Look for shade and take lots of breaks.

### Fireworks Safety

- Obey all local laws regarding the use of fireworks. **Fireworks permit for Town of Clayton is \$10.00.**
- Know your fireworks, read the cautionary labels and performance descriptions before igniting.
- Always have a bucket of water and charged water hose nearby.
- Sparklers can heat up to 1,200° and little arms are too short to hold them. Use glow sticks instead!

## Abandoned Vehicle Ordinance



At the Town Board meeting held on April 15, 2015 the Abandoned Vehicle Ordinance was approved. To summarize, if there is a vehicle(s) in the Town of Clayton that a resident feels has been abandoned they need to contact the Town of Clayton office. A notice will be sent to the owner of the vehicle at the address where the vehicle is being stored. ## Lawn and Weed Notices

**ALL TOWN OF CLAYTON LOTS MUST BE  
MOWED AND MAINTAINED AT A HEIGHT  
OF NO MORE THAN 10 INCHES TALL.**



If the office receives notice of lots that are not following this ordinance, the lot owner will receive what we call a “weed notice”. This letter gives them 10 days to mow the lot properly otherwise the Town will mow it and invoice the owner. The invoice will be at net 10 days and if unpaid will be added to your 2015 tax bill. Please help us in keeping the Town of Clayton an attractive community to live in.
