The undersigned (hereinafter the "Petitioners"), all electors and freeholders within certain territory identified herein located in the Town of Clayton, Winnebago County, Wisconsin, respectfully petition the Circuit Court to incorporate said territory as a village, a body corporate and politic with powers and privileges of a municipal corporation at common law and conferred by the statutes of the State of Wisconsin.

In support of this Petition for Incorporation, Petitioners allege:

1. The Petitioners are electors and freeholders in the Subject Territory.
2. Fifty or more persons who are electors and freeholders in the Subject Territory have signed and joined this Petition as required by §66.0203(2)(a), Wisconsin Statutes.
3. Petitioners desire the incorporation of the Subject Territory as a village, organized under Ch. 61 of the Wisconsin Statutes in accordance with the procedures set forth in Chapter 66, Wisconsin Statutes.
4. The territory proposed for incorporation consists of all lands described in the attached **Exhibit A** (herein the "Subject Territory").
5. All of the Subject Territory lies within Winnebago County, Wisconsin.

6. On June 16th, 2018 a Notice of Intention to Circulate this Petition for Incorporation was published in the Appleton Post Crescent, as required by §66.0203(1), Wisconsin Statutes. A copy of said published notice, together with copies of the Publishers' Affidavits of Publication, are attached hereto and marked as **Exhibit B**, respectively.

7. Circulation of this Petition for Incorporation was commenced no earlier than June 27th and no later than July 6th.

8. Petitioners designate as their representative Arden Schroeder, 9458 State Road 76, Neenah, WI 54956, who is an elector and freeholder in the Subject Territory; and Petitioners designate as their alternate representative Mark E. Luebke, 8425 Whispering Meadows Drive, Larsen, WI 54947 who is an elector and freeholder in the Subject Territory.

9. Attached hereto and marked as **Exhibit C** is a scale map showing the boundaries of the territory proposed for incorporation, as required by Section 66.0203(2)(c), Wisconsin Statutes.

10. The Subject Territory contains a current resident population, as required by §66.0203(2)(c), Wisconsin Statutes, of 3,951 persons, as derived from the 2010 Census Block Maps from the United States Census Bureau, which was certified as an acceptable method of determining population by the Department of Administration for the purposes set forth herein.

11. The Subject Territory is located within a metropolitan community; and such territory would constitute a "metropolitan village" as defined by §66.0203(2)(e), Wisconsin Statutes.

12. The Subject Territory meets and exceeds the minimum requirements for incorporation of a metropolitan village as established in §66.0203(2)(e) and 66.0205(3), Wisconsin Statutes, as shown below:

- a. The proposed metropolitan village has a resident population exceeding 2,500 persons in that it has a minimum of 3,951 resident persons.

- b. The proposed metropolitan village has a minimum population density of at least 500 persons in any one square mile.
- c. The proposed metropolitan village has a minimum area of 6 square miles in that it exceeds 18.67 square miles.

13. The Subject Territory meets the standards set forth in §66.0207(1), Wisconsin Statutes, as shown below:

- a. The Subject Territory is reasonably homogeneous and compact, taking into consideration natural boundaries, natural drainage basins, soil conditions, present and potential transportation facilities, previous political boundaries, boundaries of school districts, shopping and social customs.
- b. The portion of the Subject Territory beyond the most densely populated square mile of the Subject Territory has the potential for residential or other urban land use development on a substantial scale within the next three (3) years.

14. The proposed incorporation is in the public interest considering the following criteria specified in §66.0207(2), Wisconsin Statutes:

- a. The present and potential sources of tax revenue available to the Subject Territory to defray the present and anticipated costs of governmental services thereon at a local tax rate compare favorably with tax rates in similar areas for similar services.
- b. The level of governmental services desired or needed by the residents of the Subject Territory is in line with the level of governmental services to be offered by the proposed village; and the level of governmental services to be

offered by the proposed village is more appropriate than the level of governmental services available from any contiguous municipality which may file a certified copy of a resolution indicating a willingness to annex the territory designated in this Petition pursuant to §66.0203(6), Wisconsin Statutes.

- c. The proposed incorporation will not substantially hinder the solution of governmental problems and will facilitate the solution of governmental problems by providing an adequate social and economic base to meet the health, safety and welfare needs of the residents in the Subject Territory.


15. Petitioners respectfully request that the Subject Territory, when incorporated, be incorporated as the Village of Larsen.

16. Multiple counterpart copies of the Petition for Incorporation were contemporaneously circulated but are filed together herein and constitute a single "Petition" as defined by §66.0203, Wisconsin Statutes.

WHEREFORE, the undersigned Petitioners respectfully request that the Court issue an Order requiring a referendum as provided for in §66.0211, Wisconsin Statutes, and to certify the incorporation of the proposed village when it is found that all requirements have been met.
